

Minutes of the meeting of Bangor City Council held at Penrhyn Hall on **17<sup>th</sup> July 2023** at 6.30 pm.

### **31/23 DECLARATION OF FINANCIAL INTEREST OR PERSONAL CONNECTION**

### **32/23 PUBLIC PARTICIPATION**

- (i) County Councillor Dafydd Meurig, Cabinet Member for Environment, addressed the Council and discussed Cyngor Gwynedd's recent implementation of the policy to charge retailers for placing tables and chairs outside of their premises. Cllr Meurig explained that this was a County-wide policy. Following his address he asked the Council for its views. The City Council made Cllr Meurig aware of the recent social media campaign against this policy and it also made the case that, given the retention problems on the High Street and the number of empty buildings, Bangor should be considered a special case. Cllr Meurig listened to the views of the City Council and stated he would take these to Cyngor Gwynedd and report back in the fullness of time.

### **33/23 CITY DIRECTOR'S REPORT**

*Report circulated before the meeting.*

The City Director's report had been pre-circulated in advance of the meeting. The Report detailed a range of updates to Council initiatives and events, including the recent attempt to purchase a High Street building for community use, the success of Mayor's Sunday, which had been organised entirely by the Deputy Director, the recent Windrush Commemorations, the recent visit to Soest as part of the 50<sup>th</sup> anniversary of the Town Twinning initiative and the upcoming Yes Cymru rally, scheduled to take place in Bangor during the second half of September.

### **34/23 TO APPROVE MINUTES OF THE COUNCIL MEETING OF THE 5<sup>th</sup> JUNE 2023**

**IT WAS RESOLVED:** that the minutes are a true and accurate record of the Council Meeting of the 5<sup>th</sup> of June 2023.

### **35/23 TO APPROVE THE DRAFT STATEMENT OF ACCOUNTS AND ANNUAL RETURN.**

*The draft statement of accounts and annual return had been pre-distributed in advance of the meeting.*

The City Director reported that supplemental to the Statement of Accounts and Annual Statement that had been pre-circulated, the Internal Audit report had been received early that day. While the Report will be discussed at the next Council meeting, it was reported that there were no significant financial issues in the report.

**IT WAS RESOLVED:** to accept the Statement of Accounts and the Annual Report and the Council also resolved to thank the City Director and his team for their diligence and hard work.

### **36/23 TO APPROVE COUNCIL DOCUMENTS**

*The City Council's Financial Risk Assessment and Investment Strategy had been pre-circulated.*

It was reported that the City Council's Financial Risk assessment had been reviewed and minor amendments made. An Investment Strategy had been prepared and published for the first time.

**IT WAS RESOLVED:** to approve and accept the two Council documents as circulated those being i) Investment Strategy & ii) Financial Regulations

### **37/23 YOUTH CENTRE FOR YOUNG PEOPLE.**

Two proposals were discussed connected to young people:

- i) Mobile Centre: It was reported that North Wales Police are proposing that a new initiative be explored to establish a mobile youth centre, jointly led and funded by the City Council, Caernarfon Town Council and the Police. Such a mobile centre would be deployed to areas where young people gather and would spend half its time in Bangor and half in Caernarfon. Such initiatives elsewhere have led to a reduction in anti-social behaviour.
- ii) Static Centre: It was further reported that Cyngor Gwynedd has been struggling to recruit a youth worker for the previously approved Coed Mawr youth centre, while the Tryfan youth group, previously established in Ysgol Tryfan are looking for a new home. A detailed discussion on these issues ensued.

**IT WAS RESOLVED:** i) to authorise the City Director to work with North Wales Police and Caernarfon Town Council to explore the proposal further. ii) There was no amendment to the current policy on the static youth centres.

### **38/23 TO DISCUSS A GRANT FOR THE FIREWORK NIGHT AND THE CHRISTMAS CRACKER.**

The Council was asked to financially support the 2023 Firework Night and the Christmas Cracker for the same amount as last year. The previous year's events had been deemed a great success with, according to Police figures, several thousands of people attending. The Council discussed the events in detail and it was acknowledged that these requests were being made much earlier than in previous years.

**IT WAS RESOLVED:** to confirm that Firework Night be funded by the Council up to £5,000, as per the annual budget and £10,000 be approved towards the Christmas Cracker.

### **39/23 TO DISCUSS A REQUEST TO SUPPORT A SUMMER HOLIDAY PROGRAMME.**

As some required information had not been received by the Council prior to the meeting, this item was deferred.

### **40/23 TO APPROVE INCREASING THE NUMBER OF SAKURA TREES IN ASHLEY JONES FIELDS**

Following a short discussion, during which the Council suggested planting different tree types, the item was deferred to obtain more information and options.

#### **41/23 TO APPOINT REPRESENTATIVES TO OUTSIDE BODIES**

The City Council appointments to outside bodies list were reviewed and updated. Appointments to be representative at One Voice Wales meetings were appointed.

**IT WAS RESOLVED:** to approve the list of appointments to outside bodies.
