164/15 PRESENTATION

Councillors received a presentation by Richard Keatinge on the proposals by Beicio Bangor for a cycling schools link .

The presentation focused on a proposed dutch style cycle route connecting communities with schools and key sites within the city, the link would run from Maesgeirchen through to Penrhosgarnedd. The route would also involve safety space separated from highways a route through the High Street where there was a high footfall, closing of any central reservations on roadways to provide space for cycle track and importantly it would provide children and young people with independence and a healthy way to travel.

Members considered the issues raised in the proposed link and the presentation but could not support the proposal due to the many issues raised which included health and safety hazards on the High Street hazards with traffic one-way systems, no detail of the financial background and the fact that the plan was not at a final stage which clearly needed some additional work.

The Chairman thanked Mr Keating and his colleagues for attending and giving the presentation to the City Council.
