C20/0603/11/DT Single storey rear extension. 9 Lôn Y Brodyr. **No Objection**

C20/0604/11/LL Conversion of existing dwelling into 2 dwellings. 33 Stryd William. **No Objection**

C20/0610/11/LL Change of use from residential care home for the elderly and flat into a dwelling and an additional flat (3 residential units) together with alterations to parking spaces. Elm Bank, Ffordd Siliwen. **No Objection**

C20/0636/11/DT Application to erect a two storey side extension and a single storey extension to the rear of the dwelling. 26 Llys Adda. **No Objection**

C20/0642/11/DT Householder application for single storey flat roofed extension. 124 Cilgant Pennant. **No Objection**

C20/0669/11/LL Application to demolish existing buildings and erect a 4 storey building to create 36 residential units, associated vehicular parking spaces, amendments to the existing vehicular access and creation of new vehicular access. Blenheim House Ffordd Caergybi, Bangor.

The City Council oppose this application on a number of grounds: a) The design is not in keeping with area; b) the development is excessive in scale and height for the size of the plot. Which will result on an overdevelopment; c) this is a heavily pedestrianised area, used extensively by school children and students (both Coleg Menai and Bangor University); d) the establishment of an entrance to the proposed car park, will remove part of pavement on Convent lane and Holyhead road, which will be detrimental to pedestrian safety. It will also create a junction adjacent a busy bus stop increasing the dangers of road traffic collisions, as drivers views are obstructed by the buses; e) the development will dominate listed nearby buildings and will overlook and overshadow the City's railway station; f) the proposal does not comply with the bio-diversity elements of PPW 10 as there is limited space for greenery for size of plot.
