170/15 URGENT BUSINESS

The Town Clerk announced the sad death of former Councillor Eddie Dogan and gave details of the funeral arrangements. The Deputy Mayor proposed a minute's silence in the memory of Eddie. The minutes silence therefore ensued.

Councillors paid tribute to Eddie who was a standing Freeman of the City of Bangor and had spent many years serving on the City Council and Gwynedd Council. His service to the City was second to none and he had been held in the highest of esteem by his colleagues and peers. Councillors had admired his work over the years and no matter what political party he worked under he gave all he could in the best interests of parishioners in his Ward and the citizens of Bangor, he was a Bangorian in the truest sense of the word.

It was noted that Eddie had a great deal of support for Bangor City Football Club and he was a colourful character well liked and respected by all who came into contact with him. Many Members indicated that they would be attending the funeral which was to be held on 4th February at St. James Church at 12 noon finally Members noted with sadness that he would be a great loss to the City of Bangor as well as to the wider County of Gwynedd.
