15 APPOINTMENT OF COMMITTEES

- 1.1 The City Council presently has two main committees, which are:
- The Finance and General Purposes Committee
 - The Planning and Amenities Committee

It is **RECOMMENDED** that for the next 12 months the City Council continue with this arrangement.

- 1.2 The Finance and General Purposes Committee will consider general policy matters, financial, staffing and property issues and will have delegated authority to approve invoices for payment. Sub-committees, working groups and panels are appointed as and when required to deal with specific issues.
- 1.3 The Planning and Amenities Committee will consider planning applications, enforcement/appeal matters, licensing applications, other general licensing issues and consultations on Road Traffic and Highways Regulations. The Committee will have delegated authority on these consultations. It will also deal with general operational matters involved with Council property and amenity issues and will have delegated authority to approve invoices for payment if necessary.
