### 106/18 URGENT BUSINESS

The Town Clerk reported that Gwynedd Council had launched a new consultation on “Which Services are important to you?” Comments and responses could be submitted on-line by 2 November 2018.

Councillor D Hainge reported that Saturday 29th September would launch the start of “Black History Month” with an event in Bangor. It was a month long pan Wales celebration of contributions made by people of African descent in Wales. The Mayor would open the programme of events.

### 107/187 APPOINTMENT OF INTERNAL AUDITOR

**RESOLVED** that Gwynedd Council Audit Service be re-appointed as the City Council's Internal Auditor for the year 2018/19.

### 108/18 CAR PARK SCHEME

The Town Clerk reminded Members of the previous debate on this scheme whereby a 10% levy could be added to car parking charges in the City to fund projects that were of benefit to the locality in terms of Environment, Social or Economic. On 6 July the Town Clerk had circulated full details of the scheme and the finances available.

The Committee had a full and considered debate on the benefits and disbenefits of adopting such a scheme.

There appeared to be some uncertainty as to whether the sum of money involved would be worth the effort and increased car park fees of 10%. Also the City Council would have to identify particular schemes or projects prior to making a decision to the offer up.

**RESOLVED:** that this matter be considered initially by the sub-group set up to look at Gwynedd Services by the Planning & Amenities Committee (Minute 100/18).

### 109/18 PIER UPDATE & EXPENDITURE

The Town Clerk reported progress at the Pier head which was now the main focus of the repair and refurbishment works. He also reported upon the financial position including figures for budget, commitments, projections and suppliers of goods and services. The current and projected expenditure schedules together with list of payees had been shared with and approved the Financial Approvers in accordance with Standing Orders.

**RESOLVED:** that the report be received, noted and that the financial position be approved and figures noted.

110/18 FINANCIAL MATTERS

- a) **Invoices for Payment** - It was noted that invoices as detailed on the schedule totalling £15,736.37 had been approved.
- b) **Quarterly Accounts** - The quarterly accounts for the 1<sup>st</sup> quarter (April – June 2018) of the financial year were reported, this included both the revenue and capital budgets. Some members expressed concern that there were nearly three months old but accepted that there had not been a Finance & General Purposes Committee since then.

In order to have the most up to date cleared monthly figures it would be necessary to either circulate by e-mail, or report into the more regular Planning & Amenities Committee or Council Meetings along with the invoice schedules.

**RESOLVED:** that regular update of Summary Income & Expenditure reports be circulated with the papers of any appropriate meeting but the main focus for financial matters and decisions would automatically be the Finance & General Purposes Committee.
