**347/19 TOWN CLERK'S FINANCIAL REPORT**

**348/19 ESTIMATES OF INCOME AND EXPENDITURE**

The Acting Town Clerk provided an overview of the budgetary headings and the changes for next year. He provided an explanation on budget increases and priorities over the coming months. The Council discussed the budgetary headings and how best to utilise the budget for the next financial year. The Acting Town Clerk responded to questions by members.

**349/19 PRECEPT 2021/22**

The recommended Precept of £388,850 was discussed by the Council. In light of the ongoing Covid19 pandemic and the difficult times facing Bangor residents over the past year and the forthcoming months, it was agreed that the Council should not increase the tax, thus saving every Band D Household the sum of £100-98.

**RESOLVED:** To keep the existing precept of £388,166. Proposal approved and taken to Full Council

The Council also discussed Public Health Wales figures involving Covid19 vaccinations in Bangor. It was brought to the Council's attention that the figures include 'Bangor South', a geographical area previously not used and not known to members.

**RESOLVED:** That urgent clarification is sought by the City Director on the definition of 'Bangor South' and that this is taken to Full Council
