## **115/16 PLANNING APPLICATIONS**

**RESOLVED:** that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below: -

**C16/1251/11/LL** Variation of condition 2 of planning permission C13/0848/11/LL in order to extend the period during which the development can remain on site. Tir Na Nog, Normal Site, Ffordd Caergybi, Bangor. **No objection.**

**C16/1300/11/LL** Erection of a second floor extension on top of the existing rear extension including erecting a minaret and dome (amended application to that approved under re. no. C16/0612/11/LL). Bangor Islamic Centre, 57 & 61 High Street, Bangor. **No objection.**

Councillor M Shultan declared an interest in the above application and left the room, Councillor G O Roberts took the Chair for this item.

**C16/1306/11/LL** Change of use of the offices on the first, second and third floors to provide 7 living units. 205-207 High Street, Bangor. **No objection.**

**C16/1341/11/LL** Application for the erection of 2 one-bedroomed flats (amended scheme to that refused on appeal under re. no. C15/0198/11/LL) Land at York Place, Bangor. **Objection – over development of this small site.**

**C16/1343/11/LL** Change of use from former office (B1 use class) to fitness studio (D2 use class) Former Manager's Office, Bangor Railway Station, Holyhead Road, Bangor. **No objection.**

Councillor D Hainge declared an interest in the above application took no part in the discussion or voting thereon and left the Chamber.

**C16/1356/11/LL** Change of use of land to enable the siting of a mobile catering unit. The Pine Mine, Holyhead Road, Bangor. **Objection – Likely to cause traffic congestion and danger to road users and pedestrians due to its proximity to a busy road and roundabout. Also lack of proper car parking arrangements.**

**C16/1362/11/LL** Change of use of the 1st, 2nd & 3rd floors from a flat to an 8 bed house of multiple occupation. Fflat A, 4 , College Road, Bangor. **No objection.**

**C16/0677/11/LL** Erection of a 4 storey building to provide two shops and 15 living units for Students 146-152 High Street, Bangor. **Objection – over development of the site.**

Councillor Mrs J Marshall, as a Member of the Gwynedd Council Planning Committee, did not vote and took no part in the discussion on any of the above applications apart from the applications within her own Ward.

**116/16 PROPERTY & AMENITY LAND**

The Town Clerk reported the latest update on the Pier Consultancy and works supervision contract. He informed Members that a Meeting was to be held with a senior officer of Gwynedd Council on 15<sup>th</sup> November and there would be the excavation of inspection pits around the support poles of the pier on the same day.

The Town Clerk reported that he had made investigations into the availability of using Dargie Fields for an alternative use and highlighted the problems with regards to drug usage the sporadic incidents of needles and sharp objects that had been encountered when the workforce were on site. The Clerk suggested that alternative uses would be beneficial in making the site safe for the general public, visitors and workforce alike. He indicated that there was a restrictive covenant attached to the Deeds of the site which was prohibitive to any alteration or change of use.

Councillors discussed the possibilities of changes to the site and asked that the Town Clerk investigate a suitable use or alternative to the removal of the restricted covenant in order that the site be made safe in respect of health and safety matters.
