### 61/17 ONE VOICE WALES

The Chairman introduced the Chief Executive of One Voice Wales, Lynn Cadwallader who outlined the history of the organisation, its aims, desires and achievement so far.

Mr Cadwallader explained what were the key services provided by OVW as well as its representation role within the Public Service, particularly regarding liaison and interaction with Welsh Government He outlined the big challenges facing Town & Community Councils and the likely reformation of the Councils into larger blocks or clusters.

There was a brief question and answer session and the Chairman thanked Mr Cadwallader for his interesting and informative presentation.

### 62/17 URGENT BUSINESS

a)The Town Clerk updated Members on the Pier Restoration Project. He indicated that a small sub-group of Members would be required to act as the Client part of the contract and also to enable Members to be briefed on progress and action.

b)Emergency Committee – **RESOLVED:** that a Committee comprising of the Mayor, Deputy Mayor, the Chairmen and Vice Chairmen of the Planning and Amenities and the Finance and General Purposes Committees and the Senior Member of the Council be appointed to consider any emergency items which may arise during the August recess and to give that Emergency Committee Powers to Act on behalf of the Council on any such matter.

The Town Clerk announced that a Welsh Guards Freedom Parade would take place in the City on Tuesday 12 September. The Mayor and other dignitaries would inspect the Guards and take a salute.

c)A letter from Gwynedd Council had been received confirming that the Public Conveniences Partnership Scheme would continue into 2018/19 under the same conditions and costs as the current financial year.

d) Cllr Pickavance commented on the success of the Bangor Carnival and associated events over the last weekend.

Also it is recommended that Beech trees should not be subjected to crown reduction but a regime of regular pruning. The expert opinion of Gwynedd's Tree Officer should be sought on this matter.**
