97/18 URGENT BUSINESS

- a) **TRIBUTE** - The Chairman referred to the death of former Mayor of the City and Councillor Hugh Williams. Members stood in silent tribute as a mark of respect.

98/18 BANGOR BID – Presentation by Haydn Davies, Chairperson

Mr Haydn Davies updated the Council on the work and projects undertaken by Bangor BID during its two and a half years in operation. He raised concerns about Business Rates and its detrimental effects on trading conditions in the High Street.

Mr Davies indicated that BID had participated in Partnership working with several bodies including the City Council but suggested more could be done to improve the image of the City and its perception to visitors and that BID would support any marketing campaigns that would improve Bangor's image.

99/18 PLANNING APPLICATIONS

RESOLVED: that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below: -

C18/0541/11/LL Convert part of vacant shop to create 3 self-contained flats (flats 1,3 and 5) together with internal and external alterations to include a rear extension. 103, Stryd Fawr. **No objections, however the City Council has concerns about waste disposal and collection and the Planning Officers should ensure there is an appropriate space available for bin storage.**

C18/0749/11/HY Siting of non-illuminated sign 4-5, Kyffin Square **No objections.**

C18/0761/11/CR Install solar panels on the roof. Prifysgol Bangor, Ffordd y Coleg. **No objections.**

C18/0762/11/CT Fell a Beach tree within a Conservation area. Pontio Building, Prifysgol Bangor University, Ffordd Deiniol. **No objections – the City Council would request that a new tree be planted to replace the one being felled.**

C18/0765/11/HY Illuminated advertisements for the existing A.T.M. 13 Ffordd Caergybi. **No objections.**

C18/0788/11/LL Conversion of previously used hairdressers into 2 self-contained flats together with a 2 storey extension at the rear. 105 Stryd Fawr. **No objections, however the City Council has concerns about waste disposal and collection and the Planning Officers should ensure there is an appropriate space available for bin storage.**

C18/0790/11/HY Illuminated fascia and projecting sign. 246 – 250 High Street. **No objections.**

C18/0791/11/LL Conversion of ground floor into 2 self-contained units and an extension at the rear. Prydwen, 5, Ffordd Caergybi, Bangor **Objection – this represents an overdevelopment of the existing HMO. Increasing from 7 to 9 occupants would make the property cramped and reduce the quality of living for tenants. There would also be an exacerbation of issues with waste disposal and rubbish at the rear of the property which already had issues.**

C18/0796/11/R3 Demolish existing primary school and erect a new primary school in its place including new access roads, playing fields and ancillary works. Ysgol Garnedd, Penrhosgarnedd. **No objections, however there were concerns regarding the effects on increased traffic on adjoining streets during construction, the amount and six of site traffic, the affect on the condition of roadways through damaged surfaces and the traffic management plan in terms of road safety for motorists and pedestrians.**

Councillors Derek Hainge, Medwyn Hughes, John Martin, John Wynn Jones, John Wyn Williams declared an interest (as School Governors) and withdrew from the meeting during the debate on this application.

C18/0815/11/LL Single storey extension. Sorrento, Ffordd Glanaethwy. **No objections.**
