### 213/17 APOLOGIES

### 214/17 DECLARATION OF FINANCIAL INTEREST OR PERSONAL CONNECTION

### 215/17 URGENT MATTERS

The Town Clerk reported on the following matters:-

- a) **Welcome to Bangor Signs** – After some delay due to highways regulations this matter was now progressing satisfactorily.
- b) **Grass cutting/maintenance** – The Town Clerk had met with Steffan Jones, Head of Maintenance at Gwynedd Council to explore new and innovative ways of combining resources to better serve the inhabitants and visual amenity of the City. The Town Clerk was awaiting full details of Gwynedd’s schedule and options available.
- c) **Temporary Operatives** – The Town Clerk informed the Committee that job adverts had been circulated for these positions.
- d) **20 mph Schemes** – Gwynedd Council had indicated that there were no new plans to extend the current 20mph schemes in the City.
- e) **Roundabout Sponsorship** – The Town Clerk had not received a great response from Gwynedd Council on any proposals for roundabout sponsorship. He would continue to pursue this matter.
- f) **Car Park Remuneration Scheme** – The Town Clerk informed Members that a Gwynedd Council Scheme related to a 10% levy on all public car parking charges could be raised and income generated could be used by the City Council to benefit social, economic and environmental schemes in the City. There would be a £500 management fee payable to Gwynedd Council. The Town Clerk asked for a view on the proposed scheme.

**RESOLVED:** That the Town Clerk ascertain what income would be generated and that this matter be placed on the agenda of the Planning & Amenities Committee to be held on 23 April 2018.

### 216/17 PIER UPDATE

The Town Clerk reported progress with the Pier Project in terms of work undertaken, problems encountered and timescales for future work.

A financial breakdown of costs incurred, committed funds, estimates and contingency figures were presented for any comments.

Financial approvers under the Financial Regulations had received and accepted a detailed spreadsheet of the financial situation.

**RESOLVED :** that

- a) progress on works be noted;
- b) the financial report be received and approved; and
- c) it be noted that the Financial Approvers under the Council’s Financial Regulations had received and accepted full details and would continue to be updated on the financial situation.

### 217/17 INDEPENDENT REMUNERATION PANEL FOR WALES - Members Allowances

The Town Clerk had circulated a written report on the implications for the City Council on the publications of the report of the Independent Remuneration Panel for Wales (IRPW). Town and Community Councils were classified into three groups for Members Allowances’ payment and as the City Councils finances exceeded £200,000 it was classified into the highest “Group A”.

The following were therefore mandatory:

- a) £150 annual allowance (except those in receipt of certain Principal Authority payments);
- b) £500 annual allowance for at least one “senior member” appointment and up to five appointments;
- c) Authorised travel and overnight costs;
- d) Authorised care costs;
- e) Authorised financial loss costs;
- f) Civic Mayoral allowance up to £1500;
- g) Civic Deputy Mayoral Allowance up to £500

Notes

- All payments (b) (f) and (g) would be in addition to the basic £150 allowance
- Any member may opt out
- Payments for expenses on “Approved Duties” only
- The City Council must publicise its list of payment made to Members
- Receipts required for payment (c) (d) and (e)

**RESOLVED:** that

- a) The report be received, noted and adopted;
- b) The Mayor of the City Council be appointed as the “Senior Member” to receive and allowance of £500 in addition to the £1,500 Mayoral Allowance; and
- c) The Deputy Mayor be paid £500 p.a. as per the budget already agreed.

#### **218/17 STRENGTHENING LOCAL GOVERNMENT; Delivering for People – Green Paper**

Members had received details of the public consultation being carried out by Welsh Government on the Green Paper issued and accessible via the Welsh Government’s website. The consultation commenced on 12 March and would close on 12 June 2018. The Paper contained details of proposed merger of the Principal Authorities in Wales with the exception of Powys. For North Wales it proposed merging six authorities into three to include locally the merger of Ynys Mon and Gwynedd Councils.

Members considered the issues relating to the proposed merger and the current ongoing review of Town & Community Councils which would remain separate to the Green Paper Consultations.

**RESOLVED** : that no objections be made to the merger of Ynys Mon and Gwynedd Council, but that it should be recognised that there are many barriers and cultural differences to be overcome by this merger. It should be noted that bigger organisations are not necessarily better or deliver better value services and that some services are better delivered locally, which should enable Town and Community Councils to have more powers and the ability to deliver more local services.
