33/18 APOLOGIES

Apologies for absence were received from His Worship The Mayor Councillor John Wynn Jones, Councillors Conor Savage and Huw Wynn Jones.

34/18 DECLARATION OF FINANCIAL INTEREST OR PERSONAL CONNECTION

Councillor M Hughes declared an interest in Planning Application **C18/0238/11/LL** as a tenuous connection to one of the applicants.

35/18 APPOINTMENT OF VICE-CHAIRMAN

RESOLVED: that Councillor Owen Hurcum be appointed Vice-Chairman for the remainder of the Municipal Year.

36/18 URGENT BUSINESS

The Town Clerk reported on the following matters:

- i) **Bangor Market:** The Bangor Market Company had now signed the Memorandum of Understanding to enable the City Council to operate Bangor Market every Friday over the next three years.
- ii) **Closure of Pierhead:** It was noted that the Pierhead and tea Pavilion had been closed due to an adverse structural and engineering report which meant the area could not guarantee safety to members of the public or the pavilion tenants. It was likely to be closed off for approximately nine months whilst the structure was made safe. Various questions were responded to about additional costs, updated financial report, renovation progress, toilet facilities, information to the public and effect on tenants/kiosks at the pier.
- (iii) Councillor Keith Jones raised a number of questions regarding **grass cutting and grounds maintenance** in Bangor. Concern was expressed from many Members that Gwynedd Council had not been particularly proactive in assisting this matter. The Town Clerk reported that he had not had the promised agreement to assist in this area and unless permission and agreement from Gwynedd Council was forthcoming, the City Council were unable to undertake any such maintenance as it would be unlawful and would be without adequate insurance cover. Members also raised the issue of sponsored roundabouts and verges to which Gwynedd Council had not responded. This was a very frustrating matter for Local Members who were unable to push ahead and improve the appearance of the City.

RESOLVED: that this matter be placed on the agenda for the Bangor Image Partnership meeting on 9 July for a direct discussion between City Council Members and senior Gwynedd Officers/Cabinet Member
