Members also noted that community engagement was important and the setting up of a Member Sub-Group to go through the detail would be particularly helpful in the whole process.

With regard to the leasing out of the Pavilion on the Pier, the anticipated closing date was near and in order to consider applications it was now necessary to appoint a Panel of Members to undertake the task of agreeing the successful applicant (s), (ideally 5 Members).
